YEGLINSKI ENTERPRISES, INC., PERPETUAL PARTICIPANT AGREEMENT, RELEASE AND ASSUMPTION OF RISK

In consideration of the services of Yeglinski Enterprises, Inc., operator of Rebounderz Edison, their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "YEINC"), I hereby agree to release, indemnify, and discharge YEINC, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

(2) I expressly agree and promise to accept and assume all of the risks existing in activities at YEINC. My participation in activities at YEINC is purely voluntary, and I elect to participate in spite of the risks. (3) I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless YEINC from any and all claims, demands, or causes of action, which are in any way connected with my or my child's participation in activities at YEINC or my use of YEINC's equipment or facilities, including any such claims which allege negligent acts or omissions of YEINC. I understand that this perpetual release/waiver will apply to each and every occasion that I visit a YEINC facility. (4) Should YEINC or anyone acting on their behalf, be required to incur attorneys' fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs. (5) I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have. (6) In the event that I file a lawsuit against YEINC, I agree to do so solely in the Middlesex County in the State of New Jersey, and I further agree that the substantive law of New Jersey shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in activities at YEINC, I may be found by a court of law to have waived my right to maintain a lawsuit against YEINC on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
